In case of residues that are directly generated by agriculture, aquaculture, fisheries and forestry, the material fulfils the land related sustainability requirements laid down in Art. 29 of Directive (EU) 2023/2413 (REDIII) amending Directive (EU) 2018/2001 (RED II). 3. The material supplied consists only of biomass defined as the biodegradable fraction of products, waste and residues from biological origin from agriculture (including vegetal and animal substances), forestry and related industries including fisheries and aquaculture, as well as the biodegradable fraction of industrial and municipal waste. 4. Een residu is een stof die niet het eindproduct is dat een productieproces direct beoogt te produceren; het is geen primair doel van het productieproces en het proces is niet opzettelijk gewijzigd om het te produceren.
